2. PROGRAMS/PRESENTATIONS

2.1 Ag Issues Presentation – Evelyn Mehlenbacher, Cole Bennion, Dakota Slack,
Paige Ando, Daniel Merriam, and Nathan Wagoner talked about the subject of
"Should food that contains genetically modified ingredients be labeled so that the
consumer will know that it contains those ingredients". They discussed the pros and
cons of labeling

Fillmore FFA team has competed at the district level and will compete at the state level next. Should all products containing 1 % or more of genetically altered foods have a label? Proposition 37 in California was proposed last year and voted down.

Pros

- Consumers should know what is in their food
- 60% of current food contains GMO's, consumers are not harmed by it but don't know it either
- Some religious or ethical groups may not want to buy modified crops they deserve to know what is and isn't
- Label law will get people to be more concerned about what they are labeling
- Food production will increase

Cons

- \$403,700,000 spent to show that genetically modified foods will not harm people
- Patents allow some companies to have monopoly on foods
- May make people worried with no damage to their health
- Consumers grocery bill will go up \$350-400 per year, due to equipment to separate GMO and non GMO crops, labeling and shipping costs of keeping foods separate
- Possible concern of GMO's causing allergies, could cause potential severe allergy
- With cross pollination some modified crops may grow in non modified fields

3.2 Superintendent's Report –

- Brief Article Discussion on Communicating the Board Agenda Mr. Root and the Board of Education discussed a professional development article on communicating a School Board Agenda. The article was taken from a book titled, <u>Effective School</u> <u>Board Meetings</u>, by Rene Townsend, James Brown, and Walter Buster. Mr. Root discussed and reflected on how the Board Agenda is currently communicated.
- **State Testing Update** Administration of the English test went well. Students who missed school on a test day are making it up during the makeup period. Math testing will occur on April 24-26.
- **Budget Presentations Update** Mr. Ricketts and Mr. Root are hoping to meet with the former Rotary Club, a group of retired teachers who eat breakfast together on a monthly basis and the >>> The budget hearing open to the entire public will be held on Tuesday, May 14 in the small gym.
- **Front Door Update** The local locksmith has latched the two doors, BOCES installed the wiring for the project and Simplex made sure the outdoor and interior fobs will work for the same fob. DSS is scheduled to complete the project next Wednesday if all goes well.
- Miles for Smiles Update Student presentations will occur on May 3 for students across grades K-12. The program is completely voluntary and offers students a free dental screening, cleaning, fluoride treatment, home care instructions, toothbrush / floss and sealants for students in grades 2 and 3. If a child is identified with a cavity a referral to a dentist will be shared with the parent. Of course, the parent can choose what dentist the child will ultimately see. Permission slips will be sent home to all students. Both parents who would like their child to participate along with parents who would not like their child to participate will be asked to sign and return the permission slip. Mrs. Parmenter, our school nurse is developing a web site on our school page to share more information about the program with parents and students. Mr. Root is excited about the opportunity for families to receive free dental care for their students while they are at school.
